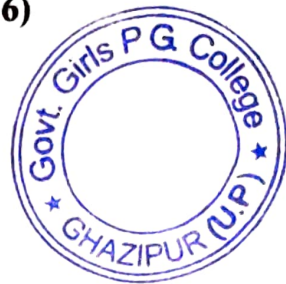

Workshop on IPR

A Workshop on Intellectual Property Rights titled '*Importance of IPR in Modern Global Economic Environment*' was conducted at Rajkiya Mahila Snatakottar Mahavidyalaya Ghazipur on 22/10/2019. The workshop was organized by the Department of Economics. Around 60 participants comprising of faculty members, researchers and students attended the Workshop. The workshop was inaugurated by the Principal Dr. Savita Bhardwaj with the enlightening lamp and her words of wisdom. Mr. Ravishekhar Singh was the key resource person. The welcome speech was given by Mr. Harendra Kumar. The Keynote Address was delivered by Dr. K.K. Srivastava. Mr. Harendra Yadav felicitated the session. The session was concluded by a vote of thanks given by Mr. Santan Kumar.

Mr. Ravishekhar Singh began his presentation by explaining the meaning of Intellectual Property Rights, its types, the process of filing and the requirements for obtaining registration for intellectual property rights. He also shared how ownership of intellectual property rights affords various rights for the protection and commercialization of such assets (which are protected by the law of intellectual property). He discussed in detail the topics like 'What is copyright?', 'What do we mean by author or creator?' The originality of Literary works, Judicial decisions (Copyright in judgments produced by courts vs government), etc. She concluded the session by discussing about

Trademark", "Service Mark and Collective mark. The presentation was much informative as he cited interesting case studies.



The second session started with the lecture of our second resource person Mr. K.K. Srivastava Assistant Professor, Department of Economics. He began his by explaining 'what is Patent'. The procedure for the application of patents and the various steps of granting patents were described. He concluded the session by explaining post-grant oppositions and Claims.

Mr. Santan Kumar laid emphasis on the need of capitalizing on Geographical Indication. He also stated that Geographical Indications tags in India are assigned to a certain product that has a specific geographical origin and possesses qualities, a reputation, or characteristics that are essentially attributable to that place of origin. GI tag represents that the product belongs to a specific area or region and contains the cultural heritage of the specific region. The tags are given to foodstuffs, handicrafts, wine and spirit drinks, industrial products, and agricultural products.

Other faculty members also expressed their views on the given topic.
